ENTRANCE FEE

For many years independent schools enjoyed a government subsidy. At Saints this subsidy was put towards capital expenditure projects. When the government decided to discontinue paying subsidies, Council was forced to review the situation and took a decision to discontinue the old style refundable deposit and implement a new, non-refundable entrance fee. The revenue raised is used for capital expenditure projects, which include the entire IT infrastructure, as well as the maintenance of the extensive grounds and other facilities at the College. This ensures that our facilities are always up to the standard expected by our parents and learners. In that sense all pupils benefit from the revenue raised.
