ANNUAL FEES are payable on or before 12 January 2025.

² The Grade RRR and RR Entrance Fee is a partial payment of the full Grades R to 9 Entrance Fee. The balance of the Entrance Fee is required by August of the year prior to entering Grade RR or R.

⁴ The Back-up Power Levy is charged to assist in funding the purchase, maintenance and operation of the generators.
