



**ST STITHIANS COLLEGE
POLICY: LYME PARK ACCESS TO SAINTS PROPERTY**

Eligibility for a key to the gate

1. The school will allow a single key to be issued to any residential unit within Lyme Park extension 4, i.e. those resident in Ahronson, Mountstephens, Hilltop and June streets.
2. More than one key will be issued to those who have children at one of the five St. Stithians schools on the basis of one key per registered learner.

Application process

3. The key(s) will be issued by an authorised resident of Lyme Park Ext 4, on the production by the applicant of the duly authorised application form. A fee may be charged to cover the costs associated with the issuing of the key.
4. The application form is available from the Operations Department at the College.
5. The user will pay an annual application fee determined from year to year by the Rector and Operations Manager.
 - 5.1 Pensioners will have a 50% discount of the application fee.
 - 5.2 Staff members living in the suburb will not pay the application fee.
6. All requests must be made on the prescribed application form and lodged with the Operations Manager.
7. All such requests shall be approved by the Operations Manager.
8. All applications will be for a period of one calendar year (1 January to 31 December), and will be automatically renewed on the payment of the annual fee.

Rules of access

9. Any losses or damages incurred will be for the account of users.
10. The College may withdraw permission to use the gate if, in the opinion of the Operations Manager, any of the rules of access have been breached.
11. No alcohol may be brought onto the premises.
12. The application form for use of the gate will constitute a contract between the user and the College.
13. Permission to use the gate does not constitute permission to use any other facilities on the premises. The use of such facilities are governed by the policy, "Facilities – Use by outsiders".
14. The gate may not be used for any motorised vehicular access, eg. motorbikes.
15. Residents may not walk their dogs on the property.
16. If a key is lost or stolen it must be reported to the authorised resident who issues the keys.
